RESOLUTION NO. 178 Series of 2024

RESOLUTION DECLARING A STATE OF CALAMITY IN THE MUNICIPALITY OF CAMILING, TARLAC

WHEREAS, the past two days proved to be nightmarish as the Municipality of Camiling, Tarlac is struck by Typhoon Carina whose onslaught has resulted in significant destruction in the municipality. It affected shelters, agriculture and the livelihood of the local populace. Initial assessments conducted by the Municipal Incident Management Team (IMT) reveal that some houses, especially those made with light materials, were severely damaged. Moreover, vast areas of farmland have been inundated, leading to the loss of crops and livestock, thus endangering food security and the economic stability of the local farmers. Many families have been displaced from their homes, requiring immediate shelter, food and medical assistance;

WHEREAS, more specifically, the following facts from the concerned offices of the LGU reveal the catastrophic effects of Typhoon Carina:

From the Municipal Social Welfare and Development Office (MSWDO):

- 8,581 families or 29,882 individuals are affected;
- Of these, 166 families or 675 individuals find shelter in evacuation centers

From the Office for Agricultural Services' (OAS) partial damage report to rice crops:

- 45 of the 51 agricultural barangays of Camiling were inundated;
- Affected are 2,756 farmers; 2,718.53 hectares or 53.98% of planted areas
- Average extent of damaged farmland is 81.22%
- The total estimated damaged cost is P91,163,402.00

From the Municipal Disaster Risk Reduction and Management Council (MDRRMC):

- The highest water level of the Camiling River is recorded at 8.44 meters. The spill point is 7.88 meters.
- River dikes are damaged in four barangays
- 18 individuals were rescued from heavy inundations
- Sacks and truck loads of sand needed be provided for sandbagging purposes

From the Municipal Engineering Office:

- Damages to river dikes occurred in nine barangays which caused heavier inundations
 - Other infrastructures like roads were damaged

WHEREAS, to address these damages and to mitigate the disruption of means of livelihood and businesses as a result of the heavy inundation our communities experience, there is a need to declare a state of calamity in the municipality in order to mitigate the effects of the typhoon and at the same time to hasten the LGU's efforts to recover from this tumultuous calamity. Such declaration shall enable the municipality to mobilize necessary resources and access emergency funds to support relief, rehabilitation and recovery operations and expedite the procurement process for relief goods and services.

On motion of SB Member Jherwin D. Corpuz, Unanimously seconded,

RESOLVED, that in view of the massive destructions brought about by the onslaught of Typhoon Carina, the Sangguniang Bayan declares, as it is hereby declared, a State of Calamity in the Municipality of Camiling, Tarlac;

RESOLVED FINALLY, that copies hereof be furnished all concerned for their information and reference.
